## **1.5 SUBMITTALS**

- G. Installer's Project References: Submit installer's list of 10 successfully completed plumbing piping insulation projects of similar size and scope to this Project, including project name and location, name of architect, and type and quantity of plumbing piping insulation installed.
- H. Warranty Documentation: Submit manufacturer's standard warranty.

## **1.6 QUALITY ASSURANCE**

- A. Manufacturer's Qualifications: Manufacturer regularly engaged in the manufacturing of plumbing piping insulation of similar type to that specified for a minimum of 10 years.
- B. Installer's Qualifications:

1. Installer regularly engaged in installation of plumbing piping insulation of similar type to that specified for a minimum of 5 years.
  2. Use persons trained for installation of plumbing piping insulation.
- C. Inspection & Verification:
1. The use of certified mechanical insulation inspectors who maintain current certification by the National Insulation Association, or other certified mechanical insulation certification association, is recommended throughout the project to inspect and verify the materials are and the total insulation system has been installed in accordance with the specifications.

## **1.7 DELIVERY, STORAGE, AND HANDLING**

- A. Delivery Requirements: Deliver materials to site in manufacturer's original, unopened containers and packaging, with labels clearly identifying product name and manufacturer.
- B. Storage and Handling Requirements:
1. Store and handle materials in accordance with manufacturer's instructions.
  2. Keep materials in manufacturer's original, unopened containers and packaging until installation.
  3. Store materials in clean, dry area indoors.
  4. Do not store materials directly on floor or ground.
  5. Store materials out of direct sunlight.
  6. Keep materials from freezing.
  7. Protect materials during storage, handling, and installation to prevent damage.

## **1.8 AMBIENT CONDITIONS**

8. Weight: Approximately 11 lbs. per gallon.
9. Solids Content: Approximately 55 percent by weight.
10. Coverage: Up to 300 ft<sup>2</sup> per gallon.
11. Reapply: Approximately every 3-5 years.
12. Shelf Life: 1 year (store at room temperature, avoid freezing).

### **PART 3 EXECUTION**

#### **3.1 EXAMINATION**

- A. Examine plumbing piping to receive insulation.
- B. Verify plumbing piping has been inspected, tested, and approved.
- C. Do not begin surface preparation or installation to plumbing piping with leaks.
- D. Notify Architect of conditions that would adversely affect installation or subsequent use.
- E. Do not begin surface preparation or installation until unacceptable conditions are corrected.

#### **3.2 SURFACE PREPARATION**

- A. Prepare plumbing piping surfaces in accordance with manufacturer's instructions.
- B. Remove moisture, condensation, dirt, dust, debris, oil, grease, coatings, and other surface contaminants which could adversely affect installation of plumbing piping insulation.

#### **3.3 INSTALLATION**

- A. Install plumbing piping insulation in accordance with manufacturer's instructions.

Specifier Notes: Include the section number for the section specifying the plumbing piping.

- B. Install plumbing piping insulation to plumbing piping specified in Section [22 10 00] [22\_\_\_\_\_] and as indicated on the Drawings.

- C. Install plumbing piping insulation at thicknesses specified for each item of plumbing piping.
- D. Install plumbing piping insulation to clean dry surfaces.
- E. Install plumbing piping insulation with least number of joints practical.
- F. Seal insulation butt joints and seams in accordance with manufacturer's instructions.

### **3.4 ADJUSTING**

- A. Repair minor damages to plumbing piping insulation in accordance with manufacturer's instructions and as approved by Architect.
- B. Remove and replace with new material, damaged plumbing piping insulation that cannot be successfully repaired, as determined by Architect.

### **3.5 CLEANING**

- A. Clean plumbing piping insulation promptly after installation in accordance with manufacturer's instructions.
- B. Do not use harsh cleaning materials or methods that could damage insulation.

### **3.6 PROTECTION**

- A. Protect Work of this Section from damage until Substantial Completion.
